1. The appointment is on purely temporary ~~and~~ and provisional basis.
2. The appointment is against a temporary post. Your confirmation against substantive post shall be considered on the basis of your seniority & record of service if and when such post is available.
3. Till you are confirmed your services are liable to be terminated at any time without assigning any reason by giving one months' notice or one months' salary or salary for such period for which the notice falls short of one month as the case may be in lieu thereof and in case you desire to resign from service you will have to give one months' notice or deposit with the Govt. one months' salary or salary for such period for which the notice falls short of one month in lieu thereof as the case may be.
