Terms & Conditions

1. He/She will be given an initial pay of Rs 2200 plus usual allowances as admissible from time to time.
2. Post is temporary but likely to continue, He/She will be on probation for a period of two years in the first instance. His/Her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service, if and when such posts are available and due to him/her.
3. Till He/She is confirmed his/her services shall be liable to be terminated without assigning any reason by giving one month notice or one month salary or salary for such period for which the notice falls short

of one month as the case may be in lieu thereof and in case he/she desires to , resign from service, he/she will have to give one month notice or deposit with the govt. one month salary or salary for such period for which the notice falls short of one month as the case may be in lieu thereof.

4. Before joining the post he/ she will have to
(a) take an oath of allegiance to the constitution of India (b) affirm that he/she is not having ~~that~~ more than one living spouse.

5. He/she will be permitted to sit in a competitive Examination once a year only. Such permission will be given on the express condition that the studies and the preparation for the competitive Examination in no way interfere with the discharge of his/her duties and he/she will not be allowed any leave for the purpose.

6. He/she is required to produce a Medical certificate of fitness for entry into Govt. Service as per the rules after joining the service. A letter asking the authority concerned to examine him/her medically will be issued by the Director of Higher Education Haryana.

7. He /She will have to undergo N.C.C. training on the compulsory basis upto the age of 35 years as and when Govt. desires.

8. He/She will have to attend at his /her own expense within the first year of his/her service a course ~~in the~~ of Lecturers in the Psychology of youth, Philosophy of Education in and general method of Education at a place to be specified by the Govt. This course will be held during the Summer Vacations.

9. His/her Seniority will be fixed in the accordance with the Department orders.

10. This appointment is further subject to the verification of his/her character and antecedents within two months of her/ His appointment.

11. Candidates who have obtained High Second class (55% marks) or grade B in seven point scale in the Masters Degree in the relevant subject ~~xx~~ will be required to obtain M.Phil Degree or a recognised degree beyond Master's level within 8 years of his/her appointment failing which he/she will not be able to earn future increments till he obtains that degree or give evidence of equivalent published work of High Standard.

12. No T.A-/D.A- will be admissible to him/her on joining the post-

13. In other matters not specifically mentioned in this communication he/she will be ~~Governed~~ governed by the Punjab Civil Service Rules as applicable to Haryana Govt. employees and such orders/instructions as may be issued by the Govt. from time to time.
