- 1. The appointment is purely temporary and on provisional basis.
- 2. The appointment is against a temporary post. The confirmation against substantive post shall be considered on the basis of seniority & record of service as and when such post is available.
- 3. Till you are confirmed, your services are liable to be terminated at any time without assigning any reason by giving one month's notice or one month's salary or salary for such period for which the notice falls short of one month, as the case may be, in lieu thereof, and in case you desire to resign from service you will have to give one month's notice or deposit one month's salary or salary for such period by which the notice falls short of one month in lieu thereof, as the case may be.

- You will be covered by the "New Defined Contributory Pension Scheme" as per 13. F.D. Notification dated 28-10-2005.
- You are directed to join immediately at Directorate i.e. O/o Director Higher 14. Education, Haryana, Shiksha Sadan, Sector-5, Panchkula.
- Your appointment is subject to the fitment of medical report. After joining, you 15. are directed to submit your medical fitness certificate issued by the Medical Board of your respective district/ Medical Board of Director General, Health Services, Haryana, Sector-6, Panchkula, of domicile as constituted by the Director General Health Services within a period of one week positively. If you are found unfit/unsuitable for appointment to Government Service on the basis of medical report, your services shall be terminated forthwith without prejudice to any other terms and conditions.
- The appointment order is subject to final outcome of CWP No. 13659 of 2017, CWP No. 14522 of 2017, CWP No. 17340 of 2017, CWP No. 14436 of 15. 2018, CWP No. 6511 of 2018, CWP No. 16220 of 2018, LPA No. 1105 of 2018. Further, the appointment order is subject to review on the basis of the outcome of various court cases/writ petitions that might have been filed and are pending in any court or may be subsequently filed.
- After joining you are required to submit four copies of character and antecedents 16. verification forms (Attestation Form) duly filled in within ten days either in person or through registered post in the office of Director Higher Education, Haryana at Panchkula. - At any stage, if the certificate/s produced by you, is/are found to be bogus or 17. defective, your services shall be terminated.
