- 15. Your appointment is subject to the fitment of medical report. After joining, you are directed to submit your medical fitness certificate issued by the Medical Board of your respective district/ Medical Board of Director General, Health Services, Haryana, Sector-6, Panchkula, of domicile as constituted by the Director General Health Services within a period of one week positively. If you are found unfit/unsuitable for appointment to Government Service on the basis of medical report, your services shall be terminated forthwith without prejudice to any other terms and conditions.

The appointment order is subject to final outcome of CWP No. 13659 of 2017, CWP No. 14522 of 2017, CWP No. 17340 of 2017, CWP No. 14436 of 2018, CWP No. 6511 of 2018, CWP No. 16220 of 2018, LPA No. 1105 of 2018. Further, the appointment order is subject to review on the basis of the outcome of various court cases/writ petitions that might have been filed and are pending in any court or may be subsequently filed.
