**Subject:-** Appointment to the post of lecturer ( College Cadre), HES.II Group "B"  
in the scale of Rs. 8000-13500/-. In the subject of Geography.

The Governor of Haryana, on the recommendations of Haryana Public Service Commission, is pleased to appoint you as lecturer (College cadre) in H.E.S.II, Group "B" in an officiating capacity in the scale of Rs. 8000-13500/- on the following terms & conditions:-

1. The appointment is on purely temporary and provisional basis.
2. The appointment is against a temporary post. The confirmation against substantive post shall be considered on the basis of the seniority & record of service if and when such post is available.
3. Till you are confirmed your services are liable to be terminated at any time without assigning any reason by giving one months notice or one month's salary or salary for such period for which the notice falls short of one month as the case may be in lieu thereof & in case you desire to resign from service you will have to give one months notice or deposit with the Govt. one months salary or salary for such period for which the notice falls short of one month in lieu thereof as the case may be.
4. You will have to take an oath of allegiance to the Constitution of India and affirm that you have not more than one living spouse in case you are married.
5. You will not be allowed to apply for any post outside the department for a period of atleast five years.
6. Your seniority will be fixed in accordance with the departmental rules.
7. You are required to serve in rural colleges of the State for the first three year after appointment.

8. You will be on probation for a period of two years in the first instance & your probation period can be extended if in the opinion of the Govt. it is necessary to do so until & unless you are appointed against a permanent vacancy.

9. Your services will be governed by Haryana Education (College Cadre) Group "B" service Rules, 1986 as amended from time to time.

10. In other matters, not specifically mentioned in this communication, you will be governed by the Civil Services Rules as applicable to Haryana Govt. Employees and such orders/instructions as may be issued by the Govt. from time to time.

11. After joining you are required to submit three copies of character verification forms duly filled in within a week positively.

12. You are required to undergo medical examinations within three weeks after joining your duty and submit the report to the department through the Principal within four weeks of your joining.

13. All newly appointed female lecturers are required to submit an affidavit duly attested by the competent authority certifying that they are not in the family way at the time of joining. However, if later on at any stage it is found that the above affidavit was untrue action as per rule will be initiated against them.

14. This appointment is subject to the decision of the case in CWP No. 10053 of 2004 -Balwan Singh and Others.

Notwithstanding anything contained in this letter, this appointment is subject to the conditions that if you are found unfit/unsuitable for appointment to Govt. service on the basis of Medical Report or on the basis of Character Verification your services shall be terminated forthwith without prejudice to other terms and conditions.

Consequently upon these appointments the Governor of Haryana is further pleased to post you as such in the college indicated against your name:-




