

Subject:- Appointment to the post of lecturer (College Cadre), HES.II Group "B" in the scale of Rs. 8000-13500/-. In the subject of Music (I).

The Governor of Haryana, on the recommendations of Selection Committee is pleased to appoint you as lecturer (College cadre) -Group "B" in Education Department (Higher Education), in the pay scale of Rs. 8000-13500/- on the following terms & conditions:-

1. The appointment is purely temporary and on provisional basis.
 2. The appointment is against a temporary post. The confirmation against substantive post shall be considered on the basis of seniority & record of service as and when such post is available.
 3. You will be on probation for a period of two years in the first instance & your probation period can be extended if in the opinion of the Govt. it is necessary to do so.

4. Till the time of your confirmation in service, Your services are liable to be terminated at any time without assigning any reason by giving one month's notice or one month's salary or salary for such period for which the notice falls short of one month, as the case may be, in lieu thereof. Similarly if owing to any reason, you desire to resign from service you will have to give one month's notice or deposit one month's salary or salary for such period by which the notice falls short of one month in lieu thereof, as the case may be.

5. You will have to take an oath of allegiance to the Constitution of India and affirm that you do not have more than one living spouse in case you are married.

6. In case you are married, you will have to furnish a declaration to the Head of Department that you have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in-law, as per Chief Secretary, Haryana letter no. 18/1/2004-2 GSI dated 21.2.2006.

7. If you are unmarried, you will have to take an oath of allegiance to the Constitution of India and affirm that you do not give or take or abet the giving or taking of dowry; or demand, directly or indirectly, from the parents or guardians of the bride or bridegroom, as the case may be, any dowry, as per Chief Secretary, Haryana letter no. 18/1/2004-2 GSI dated 21.2.2006.

8. You will not be allowed to apply for any post outside the department for a period of at least five years.

9. Your seniority will be fixed in accordance with the departmental rules.

10. You are required to serve in rural area/small town for a minimum total period of five years out of which at least three years should be prior to placement in senior scale and at least two years prior to award of selection grade. He/she shall, however, be free to opt, to do the service in rural area/small town for a period of five years at a stretch prior to the award of senior scale.

11. Your services will be governed by Haryana Education (College Cadre) Group "B" Service Rules, 1986 as amended from time to time.

In other matters, not specifically mentioned in this communication, you will be governed by the Civil Services Rules as applicable to Haryana Govt. Employees and such orders/instructions as may be issued by the Govt. from time to time.

13. You will be covered by the "New Defined Contribution Pension Scheme" as per F.D. Notification dated 28.10.2005

14. The appointment order is subject to review on the basis of the outcome of various court cases/writ petitions that have been filed or are to be filed in the Civil Court/ Punjab and Haryana High Court.

15. If you have been considered eligible for this post on the basis of NET/SLET, then your appointment is subject to the verification of NET/SLET certificate from U.G.C.


16. After joining, you are required to submit four copies of character & antecedent verification forms duly filled in within a week positively. Specimen of character & antecedent verification form is available in the office of concerned Principal.

Notwithstanding anything contained in this letter, this appointment is subject to the condition(s) that if you are found unfit/unsuitable for appointment to Govt. service on the basis of Medical Report or on the basis of character & antecedent verification your services shall be terminated forthwith without prejudice to other terms and conditions.
