The Governor of Haryana, on recommendations of Haryana
Public Service Commission, is pleased to appoint you as Lecturer
(College Cadre) in H.E.S. -II, Group 'B' in an officiating capacity

in the scale of Rs. 2200-4000 on the following terms and conditions:-

1. The appointment is on purely temporary and provisional basis.
 2. The appointment is against a temporary post. Your confirmation against substantive post shall be considered on the basis of your seniority & record of service if and when such post is available.
 3. Till you are confirmed your services are liable to be terminated at any time without assigning any reason by giving one months' notice or one months' salary or salary for such period for which the notice falls short of one month as the case may be in lieu thereof and in case you desire to resign from service you will have to give one months' notice or deposit with the Government one months' salary or salary for such period for which the notice falls short of one month as the case may be in lieu thereof as the case may be.
 4. You will have to take an oath of allegiance to the Constitution of India and you have not more than one living wife if you are married.
 5. You will not be allowed to apply for any post outside the Department for a period of at least five years.
 6. Your seniority will be fixed in accordance with the departmental rules.
7. You will be on probation for a period of two years in the first instance and your probation period can be extended if in the opinion of the Government it is necessary to do so until and unless you are appointed against a permanent vacancy.
8. Your services will be governed by Haryana Education (College Cadre) Group 'B' Service Rules, 1986.
 9. In other matters, not specifically mentioned in this communication, you will be governed by the Vicil Service Rules as applicable to Haryana Government Employees and such orders/instructions as may be issued by the Government from time to time.

Notwithstanding anything contained in this letter, the appointment is subject to the condition that if you are found unfit/unsuitable for appointment to Government service on the basis of Medical Report or on the basis of character verification your services shall be terminated forthwith without prejudice to other terms and conditions.

Consequent upon these appointments, the Governor of Haryana is pleased to post you to the following posts.
