Subject :- Appointment to the post of Assistant Professor (College Cadre), HES-II Group "B" in the subject of Geography.

On the recommendations of Haryana Public Service Commission, Panchkula the Governor of Haryana is pleased to appoint you as Assistant Professor (College Cadre), HES-II -Group "B" in the subject of Geography in an officiating capacity in the pay scale of Rs. 15600-39100+ Grade Pay 6000/- on the following terms & Conditions:-

1. The appointment is purely temporary and on provisional basis.
2. The appointment is against a temporary post. The confirmation against substantive post shall be considered on the basis of seniority & record of service as and when such post is available.
3. Till you are confirmed, your services are liable to be terminated at any time without assigning any reason by giving one month's notice or one month's salary or salary for such period for which the notice falls short of one month, as the case may be, in lieu thereof, and in case you desire to resign from service you will have to give one month's notice or deposit one month's salary or salary for such period by which the notice falls short of one month in lieu thereof, as the case may be.
4. You will have to take an oath of allegiance to the Constitution of India and affirm that you do not have more than one living spouse in case you are married.
5. In case you are married, you will have to furnish a declaration to the Head of department that you have not taken any dowry after marriage. The declaration should be signed by your wife, father and father in law, as per Chief Secretary, Haryana letter no. 18/1/2004-2GSI dated 21-02-2006.
6. If you are unmarried, you will have to take an oath of allegiance to the Constitution of India and affirm that you do not give or take or abet the giving or taking of dowry, or demand, directly or indirectly from the parents or guardians of the bride or bridegroom, as the case may be, any

dowry, as per Chief Secretary, Haryana letter no. 18/1/2004-2 GSI dated 21-02-2006.

7. You will not be allowed to apply for any post outside the department for a period of at least five years.
8. You are required to serve in rural area/small town for a minimum total period of five years out of which at least three years should be prior to placement in senior scale and at least two years prior to award of selection grade. You shall, however, be free to opt. to do the service in rural area/small town for a period of five years at a stretch prior to the award of senior scale.
9. Your seniority will be fixed in accordance with the Departmental Rules.
10. You will be on probation for a period of two years in the first instance & your probation period can be extended if in the opinion of the Govt. it is necessary to do so.
11. Your services will be governed by Haryana Education (College Cadre) Group "B" Service Rules, 1986 as amended from time to time.
12. In other matters, not specifically mentioned in this communication, you will be governed by the Civil Service Rules as applicable to Haryana Govt. Employees and such orders/instructions as may be issued by the Govt. from time to time.
13. You will be covered by the "New Defined Contribution Pension Scheme" as per F.D. Notification dated 28-10-2005.
14. You are directed to join at Head Quarter i.e. O/o Director General Higher Education, Shiksha Sadan, Sector-5, Panchkula.
15. The appointment order is subject to review on the basis of the outcome of various court cases/writ petitions that might have been filed and are pending in any court or may be subsequently filed.
16. After joining you are required to submit four copies of character and antecedents verification forms duly filled in within ten days either in person or through registered post in the office of Director General Higher Education office. The specimen of character and antecedents verification be obtained from Head Quarter.

17. At any stage if the certificates produced by you are found to be bogus or defective, your services shall be terminated. Notwithstanding anything contained in this appointment letter, your appointment is subject to condition that if you are found unfit/unsuitable for appointment to Government Service on the basis of character and antecedents
